

**Memorandum of Understanding
Institutional Partnership Agreement between
Methodist College Kuala Lumpur
And
The University of Central Missouri**

We, the undersigned agree to establish and enhance educational links between Wesleyan Education Services Sdn Bhd (Company No. 540800U) operating as Methodist College Kuala Lumpur and registered with the Ministry of Higher Education under the laws of Malaysia (hereinafter referred to as "MCKL") and the University of Central Missouri, United States of America (hereinafter referred to as "UCM"). Both parties have reached consensus on the following education objectives and student transfer to complete the baccalaureate degree via friendly consultation.

1. MCKL and UCM agree to establish formal academic transfer agreement towards progression pathway for MCKL students to further their study at UCM. UCM will admit qualified current MCKL students into the University. UCM agrees to define qualified MCKL students as those who have:
 - Completed a minimum of 24 semester hours of study before beginning study at UCM;
 - Achieved a minimum cumulative college-level GPA of 2.5 in all college-level academic coursework (all colleges attended);
 - Met the University of Central Missouri minimum English proficiency requirements by achieving a minimum grade of B in at least one English composition course or by achieving a minimum score of 5.5 IELTS or 61 TOEFL;
 - Submitted a complete transfer application and all required documents including \$75 admission application fee by the applicable admission deadline.


2. UCM and MCKL agree that:
 - MCKL will inform prospective international students of this partnership and both institutions will advertise partnership on their respected websites;
 - MCKL will assist in connecting interested students to UCM;
 - MCKL students will be responsible to submit official transcripts along with all necessary admission support documents during their final semester of study and a final transcript prior to the start of students' first semester of study at UCM;
 - UCM will offer the UCM Global Partnership Non-Resident Scholarship which results in a tuition discount equal to the non-resident tuition charge paid by international students who meet the following criteria.
 - Student transfers from an institution with whom UCM has an active partnership.
 - Student must have a cumulative undergraduate GPA of 2.5 or higher.
 - Students must maintain a cumulative undergraduate GPA of 2.5 or better each semester throughout the program to continue receiving UCM's Global Partnership Non-Resident Scholarship.

3. MCKL and UCM agree that this Memorandum of Understanding shall take effect upon signing by both institutions and shall remain in force for a period of three years. This MOU may be extended and/or reviewed at any time by mutual agreement of MCKL and UCM. Either party may terminate this MOU at any time by issuance of no less than six months advance written notice of termination to the other party.


4. The use of the other party's name, logo and/or official mark or emblem on any publication is prohibited except with the prior written approval of that party. Each party shall supply the other with the logo which may be displayed on the other party's online media and promotional materials. Any usage of the logo shall be subject to such guidelines, terms and conditions as may be issued by the party in connection with its logo. Nothing in this MOU has the effect of granting and/or transferring any right, title or benefit of any logo, mark or intellectual property of one party to the other party.

5. Each party undertakes to observe the confidentiality of documents, information and other data (including personal data) received by or supplied to it pursuant to this MOU. Subject to the Missouri Sunshine Law, each party shall use any such information solely for the purposes of this MOU, PROVIDED ALWAYS that UCM shall promptly notify and discuss with MCKL in the event of any request for records which may include the confidential information of MCKL. The confidentiality obligations under this clause shall survive the expiry or earlier termination of this Agreement for a further period of two (2) years after its expiry /termination. In the case of personal data, the parties shall comply with the provisions of all applicable and binding laws and regulations, as required.
6. Nothing in this MOU creates, implies or evidences any legal partnership or joint venture between the parties, or any principal-agent relationship. Neither party has any authority to make any representation, commitment or to incur any liability on behalf of the other.
